Sir,

I am directed to convey the sanction of the President of India for release of Rs. 12,07,200/- (Rupees Twelve Lakh Seven Thousand and Two Hundred only), as the 60% of the total approved amount Rs. 20,12,000/- (Rupees Twenty Lakh and Twelve Thousand only), as Grants -in-Aid to MCC FICCI for establishment of Model Career Center (MCC) at Greater Noida, Uttar Pradesh under Mission Mode Project for Employment Exchanges (National Career Service Project) during 2016-2017.

2- The release of grants-in-aid of Rs. 12,07,200/- (Rupees Twelve Lakh Seven Thousand and Two Hundred only), to FICCI is subject to the following terms and conditions.

- I. The MCC FICCI, Greater Noida shall strictly follow the guidelines issued vide by DGE on 10th Dec. 2014 and additional guidelines for other than Central/State Governments Institutions issued on 05.03.2015.
- II. The MCC FICCI, Greater Noida shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, related to the MCC in accordance with the Governments norms.
- III. The MCC FICCI Greater Noida shall abide by the instructions contained in the Scheme and Guidelines and orders issued from DGE time to time by the DGE.
- IV. The MCC, FICCI, Greater Noida shall strictly follow all the provisions and rules contain in chapter 09 under "GIA and Loans" of GFR-2005.
- V. The MCC, FICCI, Greater Noida is requested to utilize the said amount as first installment.
- VI. Utilization certificate issued to DGE in form GFR 19A in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- VII. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilization certificate furnished by the MCC FICCI Greater Noida.
- VIII. The MCC, FICCI, Greater Noida shall utilize the above Grants-in-Aid for Non Recurring purposes only.
- IX. Noted at serial No. 14 in Register of Grants.
- X. The above amount as Grants-in-Aid shall be spent in the Financial Year 2016-17 and in any condition not later than March 31, 2017.
- XI. The Agreement between DGE and the FICCI, Greater Noida has been signed.
- XII. This sanction issues with the approval of the Secretary, Ministry of Labour and Employment in consultation with the Integrated Finance Division of the Ministry.

The expenditure involved is debitable to Major Head "2230" – Labour & Employment for the year 2016-17 (Plan) and Sub heads/ Minor heads .02.796.02.02.31

The Section Officer (Cash Section)/Drawing and Disbursing officer, DGET, Ministry of Labour & Employment, New Delhi will draw the amount sanctioned vide para – 1 above for Rs. 12,07,200/- (Rupees Twelve Lakh Seven Thousand and Two Hundred only) and remit the same to FICCI, Greater Noida through E-remittance under intimation to DGE, New Delhi as per details.
