महोदय/Sir,

I am directed to convey the sanction of the President of India for release of **Rs. 21,58,000/- (Rupees Twenty One Lakh and Fifty Eight Thousand only)** which is 60% of **total approved amount Rs. 35,98,200/-** as Grants-in-Aid to Government of Punjab for establishment of Model Career Centers (MCCs) at Ferozpur Employment Exchanges under National Career Service Project (**Mission Mode Project for Employment Exchanges**) during 2019-2020.

2. The release of grants-in-aid **Rs. 21,58,000/- (Rupees Twenty One Lakh and Fifty Eight Thousand only)** to **Government of Punjab** is subject to the following terms and conditions:

- I. **Government of Punjab** shall strictly follow the guideline issued by DGE on **10th Dec. 2014** and other orders issued by DGE from time to time.
- II. **Government of Punjab** shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. **Government of Punjab**, shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate issued to DGE in form GFR 12C in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. The next installment of the fund would be released on the basis of actual expenditure incurred, Project outcome and utilization certificate furnished by the Government of Punjab as per GFR.
- VI. The Government of Punjab is requested to utilize the said amount as first installment.

The expenditure involved is debitable to Major Head/Sub Head (plan) for the year 2019-20 as mentioned below:



The Government of Punjab may kindly transfer the amount to Deputy/Assistant Director/District Employment Officer/DDO, Employment Exchanges, Ferozpur, Punjab.
