Subject: Grant –in-Aid to State Government of Goa, for establishment of Model Career Centers (MCCs) at the Panaji Employment Exchange under Umbrella Scheme of Skill Development Mission- General and sub scheme of National Career Service Project (Mission Mode Project for Employment Exchanges) during 2015-2016 reg.

Sir,

I am directed to convey the sanction of the President of India for release of Rs. 8,25,330/- (Rupees Eight Lakh Twenty Five Thousand Three Hundred Thirty only), which is 60% of total approved amount - Rs. 13,75,550/- as Grant –in-Aid to State Government of Goa, for establishment of Model Career Centers (MCCs) at the Panaji Employment Exchanges under National Career Service Project (Mission Mode Project for Employment Exchanges) during 2015-2016.

2- The release of grant-in-aid Rs.8,25,330/- (Rupees Eight Lakh Twenty Five Thousand Three Hundred Thirty only) to State Government of Goa is subject to the following terms and conditions.

- I. State Government of Goa shall strictly follow the guideline issued vide by DGET on 10<sup>th</sup> Dec.2014 and other orders issued by DGE&T from time to time.
- II. State Government of Goa shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. State Government of Goa, shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate issued to DGET in form GFR 19A in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilization certificate furnished by the State Government of Goa.
- VI. The State Government of Goa is requested to utilize the said amount as first installment
- VII. MOU between DGE&T and the State Government of Goa will need to be signed.

The expenditure involved is debatable to Major Head/Sub Head (plan) for the year 2015-16 as mentioned below:



The Government of Goa, may kindly transfer the amount to District Employment Officer, Employment Exchanges, Panaji, Goa.
