Sir,

I am directed to convey the sanction of the President of India for release of **Rs. 18,54,000/- (Rupees Eighteen Lakhs Fifty Four Thousand only)**, which is 60% of **total approved amount - Rs. 30,90,000 /-** as **Grants –in-Aid to State Government of Gujarat**, for establishment of Model Career Centers (MCCs) at the **Mehsana Employment Exchanges** under **National Career Service Project (Mission Mode Project for Employment Exchanges)** during 2015-2016.

2- The release of grant-in-aid **Rs. 18,54,000/- (Rupees Eighteen Lakhs Fifty Four Thousand only)** to **State Government of Gujarat** is subject to the following terms and conditions:

- I. **State Government of Gujarat** shall strictly follow the guideline issued vide by DGET on 10th Dec. 2014 and other orders issued by DGE&T from time to time.
- II. **State Government of Gujarat** shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. **State Government of Gujarat**, shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate issued to DGET in form GFR 19A in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilization certificate furnished by the State Government of Gujarat.
- VI. The State Government of Gujarat is requested to utilize the said amount as first installment.

The expenditure involved is debitable to Major Head/Sub Head (plan) for the year 2015-16 as mentioned below:



The amount of Rs. 18,54,000/- (Rupees Eighteen Lakhs Fifty Four Thousand only) may be transferred to State Government of Gujarat through Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide OM No. F-II (45/76/SC) dated 22-02-1977. The Government of Gujarat, may kindly transfer the amount to District Employment Officer, Employment Exchanges, Mehsana, Gujarat.
