Sir,

I am directed to convey the sanction of the President of India for release of **Rs. 18,19,200/- (Rupees Eighteen Lakh Nineteen Thousand Two Hundred only)**, which is 60% of total approved amount - Rs. 30,32,000/- as Grants –in-Aid to State Government of Gujarat , for establishment of Model Career Centers (MCCs) at the Sardar Patel University, Anand under National Career Service Project (**Mission Mode Project for Employment Exchanges**) during 2015-2016.

2- The release of grant-in-aid to **Rs. 18,19,200/- (Rupees Eighteen Lakh Nineteen Thousand Two Hundred only) State Government of Gujarat** is subject to the following terms and conditions.

- I. **State Government of Gujarat and Sardar Patel University** shall strictly follow the guideline issued vide by DGET on **10th Dec. 2014** and other orders issued by DGE&T from time to time.
- II. **State Government of Gujarat and Sardar Patel University** shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. **State Government of Gujarat and Sardar Patel University**, shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate issued to DGET in form GFR 19A in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilization certificate furnished by the State Government of Gujarat.

The expenditure involved is debitible to Major Head/Sub Head (plan) for the year 2015-16 as mentioned below:



The amount of Rs. 18,19,200/- (Rupees Eighteen Lakh Nineteen Thousand Two Hundred only) may be transferred to State Government of Gujarat through Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide OM No. F-II (45/76/SC) dated 22-02-1977. The Government of Gujarat, may kindly transfer the amount to Directorate of Employment, Gujarat. They are requested to further channelize the fund to Sardar Patel University (UEIGB).
