Sir,

I am directed to convey the sanction of the President of India for release of **Rs. 8,19,300/- (Rupees Eight Lakh Nineteen Thousand and Three Hundred only)** as 2<sup>nd</sup> Installment which is 20% of total approved amount – Rs 4096500 /- as Grants –in-Aid to NIELIT Srinagar, for establishment of Model Career Centers (MCCs) at the NIELIT Srinagar under National Career Service Project (Mission Mode Project for Employment Exchanges) during 2016-2017.

2- The release of grant-in-aid **Rs. 8,19,300/- (Rupees Eight Lakh Nineteen Thousand and Three Hundred only)** to NIELIT Srinagar is subject to the following terms and conditions:

- I. NIELIT Srinagar shall strictly follow the guideline issued by DGE on 10<sup>th</sup> Dec. 2014 and other orders issued by DGE from time to time.
- II. NIELIT Srinagar shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. NIELIT Srinagar, shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate issued to DGE in form GFR 19A in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilization certificate furnished by the NIELIT Srinagar.
- VI. The NIELIT Srinagar is requested to utilize the said amount as second installment.

The expenditure involved is debitable to Major Head "2230" – Labour & Employment for the year 2016-17 (Plan) and Sub heads/ Minor heads .02.789.02.02.31.

The Grants – in aid will be released in accordance with procedure laid down in the Ministry of Finance Department of Economic Affairs Office Memorandum No. 10(48) – B/68 dated 25<sup>th</sup> November 1969. The Section Officer (Cash Section)/Drawing and Disbursing officer, DGET, Ministry of Labour & Employment, New Delhi will draw the amount sanctioned vide para – 1 above of **Rs. 8,19,300/- (Rupees Eight Lakh Nineteen Thousand and**


