Sir,

I am directed to convey the sanction of the President of India for release of **Rs. 5,26,800/- (Rupees Five Lakh Twenty Six Thousand and Eight Hundred only)** as 2<sup>nd</sup> Installment which is 20% of total approved amount - **Rs. 26,34,000 /-** as Grants –in-Aid to State Government of Jammu & Kashmir, for establishment of Model Career Centers (MCCs) at the **Sambha Employment Exchanges** under National Career Service Project (Mission Mode Project for Employment Exchanges) during 2016-2017.

2- The release of grant-in-aid **Rs. 5,26,800/- (Rupees Five Lakh Twenty Six Thousand and Eight Hundred only)** to **State Government of Jammu & Kashmir** is subject to the following terms and conditions:

- I. **State Government of Jammu & Kashmir** shall strictly follow the guideline issued vide by DGE on 10<sup>th</sup> Dec. 2014 and other orders issued by DGE from time to time.
- II. **State Government of Jammu & Kashmir** shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. **State Government of Jammu & Kashmir**, shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate issued to DGE in form GFR 19A in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilization certificate furnished by the State Government of Jammu & Kashmir.
- VI. The State Government of Jammu & Kashmir is requested to utilize the said amount as second installment.


The expenditure involved is debitable to Major Head "3601" – Labour & Employment for the year 2016-17 (Plan) and Sub heads/ Minor heads .04.331.09.01.31.

The amount of Rs. 5,26,800/- (Rupees Five Lakh Twenty Six Thousand and Eight Hundred only) may be transferred to **State Government of Jammu & Kashmir** through Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide OM No. F-II (45/76/SC) dated 22-02-1977. The Government of Jammu & Kashmir, may kindly transfer the amount to **District Employment Officer, Employment Exchanges, Samba, Jammu & Kashmir.**
