I am directed to convey the sanction of the President of India for release of Rs.27,00,900/- (Rupees Twenty Seven Lakh and Nine Hundred only) which is 60% of total approved amount Rs.45,01,600/- as Grants-in-Aid to Government of Jammu & Kashmir for J&K UT for establishment of Model Career Centers (MCCs) at Kulgam Employment Exchange under National Career Service Project (Mission Mode Project for Employment Exchange) during 2019-2020.

2. The release of grants-in-aid Rs.27,00,900/- (Rupees Twenty Seven Lakh and Nine Hundred only) to Government of Jammu & Kashmir for J&K UT is subject to the following terms and conditions:

- I. Government of Jammu & Kashmir for J&K UT shall strictly follow the guideline issued by DGE on 10th Dec. 2014 and other orders issued by DGE from time to time.
- II. Government of Jammu & Kashmir for J&K UT shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc. in accordance with the Governments norms.
- III. Government of Jammu & Kashmir for J&K UT, shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate issued to DGE in form GFR 12C in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. The next installment of the fund would be released on the basis of actual expenditure incurred, Project outcome and utilization certificate furnished by the Government of Jammu & Kashmir for J&K UT as per GFR.
- VI. The Government of Jammu & Kashmir for J&K UT is requested to utilize the said amount as first installment.
