Sir,

I am directed to convey the sanction of the President of India for release of **Rs. 10,65,480/- (Rupees Ten Lakh Sixty Five Thousand Four Hundred and Eighty only)**, which is 2nd part payment of the 60% of total approved amount - **Rs. 17,75,800 /-** as **Grants -in-Aid to State Government of Lakshadweep, for establishment of Model Career Centers (MCCs) at the Kavaratti Employment Exchanges under National Career Service Project (Mission Mode Project for Employment Exchanges) during 2016-2017.**

2- The release of grant-in-aid **Rs. 10,65,480/- (Rupees Ten Lakh Sixty Five Thousand Four Hundred and Eighty only)** to **State Government of Lakshadweep** is subject to the following terms and conditions:

- I. **State Government of Lakshadweep** shall strictly follow the guideline issued vide by DGET on **10th Dec.2014** and other orders issued by DGE&T from time to time.
- II. **State Government of Lakshadweep** shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. **State Government of Lakshadweep**, shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate issued to DGET in form GFR 19A in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilization certificate furnished by the State Government of Lakshadweep.
- VI. The State Government of Lakshadweep is requested to utilize the said amount as 2nd part payment of first installment.

The expenditure involved is debitable to Major Head/Sub Head (plan) for the year 2016-17 as mentioned below:


