महोदय/Sir,

I am directed to convey the sanction of the President of India for release of **Rs. 22,63,000/- (Rupees Twenty Two Lakh and Sixty Three Thousand only)**, which is 60% of total approved amount -**Rs. 37,72,600/-** as Grants -in-Aid to UT Ladakh for establishment of Model Career Centers (MCCs) at Leh Employment Exchanges under National Career Service Project (**Mission Mode Project for Employment Exchanges**) during 2020-2021.

2. The release of Grants-in-Aid **Rs. 22,63,000/- (Rupees Twenty Two Lakh and Sixty Three Thousand only)** to **UT Ladakh** is subject to the following terms and conditions:

- I. **UT Ladakh** shall strictly follow the guideline issued by DGE on **10th Dec. 2014** and other orders issued by DGE from time to time.
- II. **UT Ladakh** shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. **UT Ladakh** shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate issued to DGE in form GFR 12C in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. The next installment of the fund would be released on the basis of actual expenditure incurred, Project outcome and utilization certificate furnished by the UT Ladakh as per GFR.
- VI. The UT Ladakh is requested to utilize the said amount as first installment.

The expenditure involved is debitable to Major Head/Sub Head (plan) for the year 2020-21 as mentioned below:

UT Ladakh may kindly transfer the amount to Deputy/Assistant Director/District Employment Officer/DDO, Employment Exchanges, Leh, UT Ladakh.
