Subject: Grants –in-Aid to **State Government of Madhya Pradesh**, for establishment of Model Career Centers (MCCs) at the **Ujjain Employment Exchange** under **National Career Service Project (Mission Mode Project for Employment Exchanges)** during **2017-2018** reg.

Sir,

I am directed to convey the sanction of the President of India for release of **Rs. 9,90,000/- (Rupees Nine Lakh and Ninety Thousand only)** as 2<sup>nd</sup> Installment which is 20% of **total approved amount – Rs 49,50,000/-** as **Grants –in-Aid to State Government of Madhya Pradesh**, for establishment of **Model Career Centers (MCCs)** at the **Ujjain Employment Exchanges** under **National Career Service Project (Mission Mode Project for Employment Exchanges)** during **2017-2018**.

2- The release of grant-in-aid **Rs. 9,90,000/- (Rupees Nine Lakh and Ninety Thousand only)** to **State Government of Madhya Pradesh** is subject to the following terms and conditions:

- I. **State Government of Madhya Pradesh** shall strictly follow the guideline issued by DGE on **10<sup>th</sup> Dec. 2014** and other orders issued by DGE from time to time.
- II. **State Government of Madhya Pradesh** shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. **State Government of Madhya Pradesh**, shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate issued to DGE in form GFR 12C in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilization certificate furnished by the State Government of Madhya Pradesh.
- VI. The State Government of Madhya Pradesh is requested to utilize the said amount as second installment.

The expenditure involved is debitable to Major Head "3601" – Labour & Employment for the year 2017-2018 (Plan) and Sub heads/ Minor heads .06.796.20.01.31.

The amount of Rs. 9,90,000/- (Rupees Nine Lakh and Ninety Thousand only) may be transferred to State Government of Madhya Pradesh through Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide OM No. F-II (45/76/SC) dated 22-02-1977. The Government of Madhya Pradesh, may kindly transfer the amount to District Employment Officer/ Deputy Director, Employment Exchanges, Ujjain, Madhya Pradesh.

Certified that no Utilization Certificate is pending in respect of the State mentioned in the Sanction Order as per requirement as this the second installment.

This issue with the approval of competent authority M/o Labour & Employment vide their letter No. DGE-M-27014/01/2016-NCS (Coord.)
