Subject: Grant –in-Aid to the NIELIT, for establishment of Model Career Center (MCCs) at NIELIT Calicut, Kerala under Umbrella Scheme of Skill Development Mission- General and sub scheme of National Career Service Project (Mission Mode Project for Employment Exchanges) during 2015-2016 reg.

Sir,

I am directed to convey the sanction of the President of India for release of Rs. 10,00,000/- (Rupees Ten Lakhs only), as a part payment towards the total amount of Rs. 24,57,900 (Rupees Twenty Four Lakh Fifty Seven Thousand Nine Hundred only) as First installment (60% of the total approved amount of Rs. 40, 96, 500/-), as Grant –in-Aid to NIELIT, for establishment of Model Career Centers (MCCs) at Calicut, Kerala under National Career Service Project (Mission Mode Project for Employment Exchanges) during 2015-2016.

2- The release of grant-in-aid Rs. 10, 00,000/- (Rupees Ten Lakhs only), to NIELIT, for establishment of Model Career Centers (MCCs) at the Calicut, Kerala is subject to the following terms and conditions.

- I. NIELIT, for establishment of Model Career Centers (MCCs) at Calicut, Kerala shall strictly follow the guideline issued vide by DGET on 10th Dec.2014 and Additional Guidelines for other-than Central/State Governments Institutions issued on 05.03.2015.
- II. NIELIT, for establishment of Model Career Centers (MCCs) at Calicut, Kerala shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. NIELIT, for establishment of Model Career Centers (MCCs) at Calicut, Kerala, shall abide by the Instructions contained in the Scheme and Guidelines and orders issued by DGE & T from time to time.
- IV. NIELIT, for establishment of Model Career Centers (MCCs) at Calicut, Kerala shall strictly follow all the provisions and rules contain in chapter 09 under "GIA and Loans" of GFR-2005.
- V. Utilization certificate issued to DGET in form GFR 19A in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- VI. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilization certificate furnished by the NIELIT, for establishment of Model Career Centers (MCCs) at Calicut, Kerala.
- VII. NIELIT, for establishment of Model Career Centers (MCCs) at Calicut, Kerala is requested to utilize the said amount as first installment.
- VIII. NIELIT shall utilize the above Grants-in-Aid for Non-Recurring purposes only.
- IX. Noted at serial No 5 in the Register of Grants.
- X. The above amount as Grants-in-Aid shall be spend in the Financial Year 2015-16 and in any condition not later than March 31 2016.
- XI. The Agreement between DGE&T and the NIELIT has been signed.
- XII. This sanction issues with the approval of the Secretary, Ministry of Labour & Employment in consultation with the Integrated Finance Division of the Ministry.
