Subject: Grant -in-Aid to the NIELIT, for establishment of Model Career Centers (MCCs) at Imphal, Manipur under Mission Mode Project for Employment Exchanges (National Career Service Project) during 2015-2016 reg.

Sir,

I am directed to convey the sanction of the President of India for release of Rs. 24,57,900 (Rupees Twenty Four Lakh Fifty Seven Thousand Nine Hundred only) as the 60% of the total amount Rs. 40,96,500/- (Rupees Forty Lakh Ninety Six thousand Five hundred only), as Grant -in-Aid to MCC NIELIT Imphal, for establishment of Model Career Center (MCC) at Imphal, Manipur under Mission Mode Project for Employment Exchanges (National Career Service Project) during 2015-2016.

2- The release of grant-in-aid Rs. 24,57,900 (Rupees Twenty Four Lakh Fifty Seven Thousand Nine Hundred only) to NIELIT, for establishment of Model Career Centers (MCCs) at the Imphal, Manipur is subject to the following terms and conditions.

- I. The MCC, NIELIT Imphal, for establishment of Model Career Centers (MCCs) at Imphal, Manipur shall strictly follow the guidelines issued vide by DGET on 10thDec.2014 and additional guidelines for other than Central/State Governments Institutions issued on 05.03.2015.
- II. The MCC, NIELIT Imphal, for establishment of Model Career Centers (MCCs) at Imphal, Manipur shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, related to the MCC in accordance with the Governments norms.
- III. The MCC, NIELIT Imphal, for establishment of Model Career Centers (MCCs) at Imphal, Manipur shall abide by the instructions contained in the Scheme and Guidelines and orders issued from DGET time to time.
- IV. The MCC, NIELIT Imphal, for establishment of Model Career Centers (MCCs) at Imphal, Manipur shall strictly follow all the provisions and rules contain in chapter 09 under 'GIA and Loans' of GFR-2005.
- V. The MCC, NIELIT Imphal, for establishment of Model Career Centers (MCCs) at Imphal, Manipur is requested to utilize the said amount as first installment.
- VI. Utilization certificate issued to DGET in form GFR 19A in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- VII. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilization certificate furnished by the MCC NIELIT Imphal.
- VIII. The fund sanctioned is of Non-Recurring nature and shall be spend for Non-Recurring purposes only.
- IX. Noted at serial No. 9 in Register of Grants.
- X. The above amount as Grants-in-Aid shall be spent in the Financial Year 2015-16 and in any condition not later than March 31, 2016.
- XI. The Agreement between DGE&T and the NIELIT has been signed.
- XII. This sanction issues with the approval of the Secretary, Ministry of Labour and Employment in consultation with the Integrated Finance Division of the Ministry.






