Subject: Grant -in-Aid to the NIELIT, for establishment of Model Career Centers (MCCs) at NIELIT Srinagar, Jammu & Kashmir under Mission Mode Project for Employment Exchanges (National Career Service Project) during 2015-16 reg.

Sir,

In continuation to the earlier order of even No. dated 26-05-2015, I am directed to convey the sanction of the President of India for release of Rs. 14,57,900 (Fourteen Lakhs Fifty Seven Thousand And Nine Hundred Only) as remaining amount of the first installment [60% of the total approved amount i.e. Rs. 24,57,900 (Rupees Twenty Four Lakh Fifty Seven Thousand Nine Hundred Only) less the part payment of Rs 10,00,000/- (Rupees Ten Lakh Only)] as Grant -in-Aid to MCC NIELIT Srinagar, for establishment of Model Career Center (MCC) at Srinagar, Jammu & Kashmir under Mission Mode Project for Employment Exchanges (National Career Service Project) during 2015-2016.

2- The release of grant-in-aid Rs. 14,57,900/- (Rupees Fourteen Lakhs Fifty Seven Thousand Nine Hundred Only), to NIELIT Sri Nagar, for establishment of Model Career Centers (MCCs) at the Srinagar, Jammu & Kashmir is subject to the following terms and conditions.

- I. The MCC, NIELIT Srinagar, for establishment of Model Career Centers (MCCs) at Srinagar, Jammu & Kashmir shall strictly follow the guidelines issued vide by DGET on 10th Dec. 2014 and additional guidelines for other than Central/State Governments Institutions issued on 05.03.2015.
- II. The MCC, NIELIT Srinagar, for establishment of Model Career Centers (MCCs) at Srinagar, Jammu & Kashmir shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure related to the MCC etc, in accordance with the Governments norms.
- III. The MCC, NIELIT Srinagar, for establishment of Model Career Centers (MCCs) at Srinagar, Jammu & Kashmir shall abide by the instructions contained in the Scheme and Guidelines and orders issued by DGET from time to time.
- IV. The MCC, NIELIT Srinagar, for establishment of Model Career Centers (MCCs) at Srinagar, Jammu & Kashmir shall strictly follow all the provisions and rules contained in chapter 09 under 'GIA and Loans' of GFR-2005.
- V. The MCC, NIELIT Srinagar, for establishment of Model Career Centers (MCCs) at Srinagar, Jammu & Kashmir is requested to utilize the said amount as first installment.
- VI. Utilization certificate issued to DGET in form GFR 19A in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- VII. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilization certificate furnished by the MCC NIELIT Srinagar.
- VIII. The fund sanctioned is of Non Recurring nature and shall be spend for Non Recurring purposes only.
- IX. Noted at serial No. 6 in Register of Grants.
- X. The above amount as Grant-In-Aid shall be spend in the Financial Year 2015-16 and in any condition not later than March 31, 2016.
- XI. The Agreement between DGE&T and the NIELIT has been signed.
