- I. NIELIT Leh shall strictly follow the guideline issued by DGE on 10thDec.2014 and other orders issued by DGE from time to time.
- II. NIELIT Leh shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. NIELIT Leh shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate should be issued to DGE in form GFR 12A in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.

V. NIELIT Leh is requested to utilize the said amount as third and final installment.

The grants - in aid will be released in accordance with procedure laid down in the Ministry of Finance Department of Economic Affairs Office Memorandum No. 10(48) - B/68 dated 25th November 1969. The Section Officer (Cash Section)/Drawing and Disbursing officer, DGE, Ministry of Labour & Employment, New Delhi will draw the amount sanctioned vide para - 1 above for **Rs. 4,50,320/- (Rupees Four Lakh Fifty Thousand and Three Hundred Twenty only)** and remit the same to NIELIT, for establishment of Model Career Centers (MCCs) at **Leh**, through E-remittance under intimation to DGE, New Delhi as per details given below.
