महोदय/Sir,

I am directed to convey the sanction of the President of India for release of **Rs. 27,69,600/- (Rupees Twenty Seven Lakh Sixty Nine Thousand and Six Hundred only)** which is 60% of **total approved amount Rs. 46,16,000/-** as Grants-in-Aid to Government of Andhra Pradesh for establishment of Model Career Centers (MCCs) at Nellore Employment Exchanges under National Career Service Project (**Mission Mode Project for Employment Exchanges**) during 2019-2020.

2. The release of grants-in-aid **Rs. 27,69,600/- (Rupees Twenty Seven Lakh Sixty Nine Thousand and Six Hundred only)** to **Government of Andhra Pradesh** is subject to the following terms and conditions:

- I. **Government of Andhra Pradesh** shall strictly follow the guideline issued by DGE on **10<sup>th</sup>Dec. 2014** and other orders issued by DGE from time to time.
- II. **Government of Andhra Pradesh** shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc. in accordance with the Governments norms.
- III. **Government of Andhra Pradesh**, shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate issued to DGE in form GFR 12C in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. The next installment of the fund would be released on the basis of actual expenditure incurred, Project outcome and utilization certificate furnished by the Government of Andhra Pradesh as per GFR.
- VI. The Government of Andhra Pradesh is requested to utilize the said amount as first installment.

The expenditure involved is debitable to Major Head/Sub Head (plan) for the year 2019-20 as mentioned below:

The Government of Andhra Pradesh may kindly transfer the amount to Deputy/Assistant Director/District Employment Officer/DDO, Employment Exchanges, Nellore, Andhra Pradesh.
