Sir,

I am directed to convey the sanction of the President of India for release of **Rs. 24,11,881/- (Rupees Twenty Four Lakh Eleven Thousand Eight Hundred and Eighty One only)**, which is part payment of 60% of **total approved amount - Rs. 44,87,000/-**, less the part payment of Rs. 2,80,319/- as Grants –in-Aid to Government of A&N Island, for establishment of Model Career Centers (MCCs) at the Port Blair Employment Exchanges under National Career Service Project (**Mission Mode Project for Employment Exchanges**) during 2016-17.

2- The release of grants-in-aid **Rs. 24,11,881/- (Rupees Twenty Four Lakh Eleven Thousand Eight Hundred and Eighty One only)** to Government of A&N Island is subject to the following terms and conditions.

- I. **Government of A&N Island** shall strictly follow the guideline issued vide by DGE on **10th Dec. 2014** and other orders issued by DGE from time to time.
- II. **Government of A&N Island** shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. **Government of A&N Island**, shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate issued to DGE in form GFR 19A in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilization certificate furnished by the State Government of A&N Island.
- VI. The State Government of A&N Island is requested to utilize the said amount as first installment.

The expenditure involved is debit to Major Head "2230" – Labour & Employment for the year 2016-17 (Plan) and Sub heads/ Minor heads .02.789.02.02.31.


