Sir,
I am directed to convey the sanction of the President of India for release of Rs.28,11,600/- (Rupees Twenty Eight Lakh Eleven Thousand and Six Hundred only) , as Grant -in-Aid to State Government of Jharkhand, for establishment of Model Career Centers (MCCs) at the Ranchi Employment Exchanges under National Career Service Project (Mission Mode Project for Employment Exchanges) during 2014-2015

2- The release of grant-in-aid Rs. 28,11,600/- (Rupees Twenty Eight Lakh Eleven Thousand and Six Hundred only) to State Government of Jharkhand is subject to the following terms and conditions.

- i. State Government of Jharkhand shall strictly follow the guideline issued vide by DGET on 10th Dec. 2014 and other orders issued by DGE&T from time to time.
- ii. State Government of Jharkhand shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- iii. State Government of Jharkhand, shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- iv. Utilization certificate issued to DGET in form GFR 19A in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- v. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilization certificate furnished by the State Government of Jharkhand.
- vi. The State Government of Jharkhand is requested to utilize the said amount as first installment
- vii. MOU between DGE&T and the State Government of Jharkhand will need to be signed.

The expenditure involved is debatable to major head 3601 Mission Mode Project Centrally Sponsored Scheme , "3601"- Labour & Employment for the year 2014-15 and major heads as mentioned below:

The amount of Rs. 28,11,600/- (Rupees Twenty Eight Lakh Eleven Thousand and Six Hundred only) may be transferred to Government of Jharkhand through Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide OM No. F-II (45/76/SC) dated 22-02-1977. The Government of Jharkhand, may kindly transfer the amount to Assistant Director, Sub Regional Employment Exchange Ranchi, Directorate of Employment and Training, Government of Jharkhand.
