Sir,

I am directed to convey the sanction of the President of India for release of Rs. 20,22,720/- (Rupees Twenty Lakh Twenty Two Thousand Seven Hundred and Twenty only), which is 60% of total approved amount - Rs. 33,71,200/- as Grants –in-Aid to State Government of Assam, for establishment of Model Career Centers (MCCs) at the Silchar Employment Exchanges under National Career Service Project (Mission Mode Project for Employment Exchanges) during 2016-2017.

2- The release of grant-in-aid Rs. 20,22,720/- (Rupees Twenty Lakh Twenty Two Thousand Seven Hundred and Twenty only) to State Government of Assam is subject to the following terms and conditions:

- I. State Government of Assam shall strictly follow the guideline issued vide by DGET on 10th Dec. 2014 and other orders issued by DGE&T from time to time.
- II. State Government of Assam shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. State Government of Assam, shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate issued to DGET in form GFR 19A in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilization certificate furnished by the State Government of Assam.
- VI. The State Government of Assam is requested to utilize the said amount as first installment.

The expenditure involved is debit to Major Head/Sub Head (plan) for the year 2016-17 as mentioned below:



The Government of Assam, may kindly transfer the amount to District Employment Officer, Employment Exchanges, Silchar, Assam.
