महोदय/Sir,

I am directed to convey the sanction of the President of India for release of **29,70,000/- (Rupees Twenty Nine Lakh and Seventy Thousand only)**, which is 60% of **total approved amount - Rs. 49,50,000/-** as Grants -in-Aid to State Government of Tamilnadu for establishment of Model Career Centers (MCCs) at Thiruvallur Employment Exchanges under National Career Service Project (**Mission Mode Project for Employment Exchanges**) during 2019-2020.

2- The release of grants-in-aid **29,70,000/- (Rupees Twenty Nine Lakh and Seventy Thousand only)** to **State Government of Tamilnadu** is subject to the following terms and conditions:

- I. **State Government of Tamilnadu** shall strictly follow the guideline issued by DGE on **10thDec. 2014** and other orders issued by DGE from time to time.
- II. **State Government of Tamilnadu** shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. **State Government of Tamilnadu**, shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate issued to DGE in form GFR 12C in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. The next installment of the fund would be released on the basis of actual expenditure incurred, Project outcome and utilization certificate furnished by the State Government of Tamilnadu as per GFR.
- VI. The State Government of Tamilnadu is requested to utilize the said amount as first installment.

The expenditure involved is debitable to Major Head/Sub Head (plan) for the year 2019-20 as mentioned below:

The amount of **29,70,000/- (Rupees Twenty Nine Lakh and Seventy Thousand only)** may be transferred to **State Government of Tamilnadu** through Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide OM No. F-II (45/76/SC) dated 22-02-1977. The Government of Tamilnadu may kindly transfer the amount to Deputy/Assistant Director/District Employment Officer/DDO, Employment Exchanges, Thiruvallur, Tamilnadu.


