Sir,

I am directed to convey the sanction of the President of India for release of Rs. 16,97,600/- (Rupees Sixteen Lakh Ninety Seven Thousand and Six Hundred only), which is 60% of total approved amount - Rs. 28,29,333/- as Grants –in-Aid to State Government of Uttar Pradesh , for establishment of Model Career Centers (MCCs) at the Allahabad University, Allahabad under National Career Service Project (Mission Mode Project for Employment Exchanges) during 2015-2016.

2- The release of grant-in-aid to Rs. 16,97,600/- (Rupees Sixteen Lakh Ninety Seven Thousand and Six Hundred only) State Government of Uttar Pradesh is subject to the following terms and conditions.

- I. **State Government of Uttar Pradesh** and Allahabad University shall strictly follow the guideline issued vide by DGET on 10<sup>th</sup> Dec.2014 and other orders issued by DGE&T from time to time.
- II. **State Government of Uttar Pradesh** and Allahabad University shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. **State Government of Uttar Pradesh** and Allahabad University shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate issued to DGET in form GFR 19A in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilization certificate furnished by the State Government of Uttar Pradesh.

The expenditure involved is debitable to Major Head/Sub Head (plan) for the year 2015-16 as mentioned below:



The amount of Rs. 16,97,600/- (Rupees Sixteen Lakh Ninety Seven Thousand and Six Hundred only) may be transferred to State Government of Uttar Pradesh through Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide OM No. F-II (45/76/SC) dated 22-02-1977. The Government of Uttar Pradesh, may kindly transfer the amount to Directorate of Employment, Uttar Pradesh. They are requested to further channelize the fund to and Allahabad University UIEGB.

Certified that no Utilization Certificate is pending in respect of the State mentioned in the Sanction Order as per requirement as this is the first installment.
