Sir,

I am directed to convey the sanction of the President of India for release of Rs. 8,96,400/- (Rupees Eight Lakh Ninty Six Housand and Four Hundred only), which is 60% of total approved amount - Rs. 14,94,000/- as Grants -in-Aid to State Government of Uttar Pradesh , for establishment of Model Career Centers (MCCs) at the Banaras Hindu University (UEIGB) under National Career Service Project (Mission Mode Project for Employment Exchanges) during 2015-2016.

2- The release of grant-in-aid to Rs. 8,96,400/- (Rupees Eight Lakh Ninty Six Housand and Four Hundred only) State Government of Uttar Pradesh is subject to the following terms and conditions.

- I. State Government of Uttar Pradesh shall strictly follow the guideline issued vide by DGET on 10th Dec. 2014 and other orders issued by DGE&T from time to time.
- II. State Government of Uttar Pradesh shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. State Government of Uttar Pradesh, shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate issued to DGET in form GFR 19A in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilization certificate furnished by the State Government of Uttar Pradesh.

The expenditure involved is debitible to Major Head/Sub Head (plan) for the year 2015-16 as mentioned below:



The Government of Uttar Pradesh, may kindly transfer the amount to Deputy Chief, University Employment Information and Guidance Bureau, Banaras Hindu University, Uttar Pradesh.
