Subject: Grant –in-Aid to State Government of Uttarakhand, for establishment of Model Career Centers (MCCs) at the Deharadun Employment Exchange under Umbrella Scheme of Skill Development Mission- General and sub scheme of National Career Service Project (Mission Mode Project for Employment Exchanges) during 2015-2016 reg.

Sir,

I am directed to convey the sanction of the President of India for release of Rs. 19,92,000/- (Rupees Nineteen Lakh Ninety Two Thousand only), which is 60% of the total approved amount – Rs. 33,20,000/- as Grant –in-Aid to State Government of Uttarakhand, for establishment of Model Career Centers (MCCs) at the Deharadun Employment Exchanges under National Career Service Project (Mission Mode Project for Employment Exchanges) during 2015-2016.

2- The release of grant-in-aid Rs.19,92,000/- (Rupees Nineteen Lakh Ninety Two Thousand only) to State Government of Uttarakhand is subject to the following terms and conditions.

- I. State Government of Uttarakhand shall strictly follow the guideline issued vide by DGET on 10<sup>th</sup> Dec. 2014 and other orders issued by DGE&T from time to time.
- II. State Government of Uttarakhand shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. State Government of Uttarakhand, shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate issued to DGET in form GFR 19A in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilization certificate furnished by the State Government of Uttarakhand.
- VI. The State Government of Uttarakhand is requested to utilize the said amount as first installment
- VII. MOU between DGE&T and the State Government of Uttarakhand will need to be signed.

The expenditure involved is debatable to Major Head/Sub Head (plan) for the year 2015-16 as mentioned below:



The amount of Rs.19,92,000/- (Rupees Nineteen Lakh Ninety Two Thousand only) may be transferred to State Government of Uttarakhand through Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide OM No. F-II (45/76/SC) dated 22-02-1977. The Government of Uttarakhand, may kindly transfer the amount to District Employment Officer, Employment Exchanges, Deharadun, Uttarakhand.
