Sir,

I am directed to convey the sanction of the President of India for release of **Rs. 7,65,600/- (Rupees Seven Lakh Sixty Five Thousand and Six Hundred only)** as 2nd Installment which is 20% of **total approved amount – Rs 38,28,000/-** as **Grants –in-Aid** to Government of Kerala, for establishment of Model Career Centers (MCCs) at the **Employment Exchange Thiruvanthapuram UEIGB (University Employment Information & Guidance Bureau)** under National Career Service Project (**Mission Mode Project for Employment Exchanges**) during 2019-2020.

2. The release of Grants-in-aid **Rs. 7,65,600/- (Rupees Seven Lakh Sixty Five Thousand and Six Hundred only)** to **Government of Kerala** is subject to the following terms and conditions:

- I. **Government of Kerala** shall strictly follow the guideline issued by DGE on **10thDec.2014** and other orders issued by DGE from time to time.
- II. **Government of Kerala** shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. **Government of Kerala** shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate issued to DGE in form GFR 12C in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. The next installment of the fund would be released on the basis of actual expenditure incurred as per scheme guidelines, project outcome and utilization certificate furnished by the Government of Kerala as per GFR.
- VI. The Government of Kerala is requested to utilize the said amount as second installment.

The expenditure involved is debitable to Major Head "3601" – Labour & Employment for the year 2019-2020 (Plan) and Sub heads/ Minor heads –
