Subject: Grants –in-Aid to **State Government of Madhya Pradesh**, for establishment of Model Career Centers (MCCs) at the Employment Exchange Sagar, under **National Career Service Project (Mission Mode Project for Employment Exchanges)** during 2019-2020 reg.

Sir,

I am directed to convey the sanction of the President of India for release of **Rs. 9,90,000/- (Rupees Nine Lakh Ninety Thousand only)** as 2<sup>nd</sup> Installment which is 20% of **total approved amount – Rs 49,50,000/- as Grant –in-Aid to State Government of Madhya Pradesh**, for establishment of Model Career Centers (MCCs) at the Employment Exchange Sagar under National Career Service Project (**Mission Mode Project for Employment Exchanges**) during 2019-2020.

2. The release of grant-in-aid **Rs. 9,90,000/- (Rupees Nine Lakh Ninety Thousand only)** to **State Government of Madhya Pradesh** is subject to the following terms and conditions:

- I. **State Government of Madhya Pradesh** shall strictly follow the guideline issued by DGE on **10<sup>th</sup>Dec.2014** and other orders issued by DGE from time to time.
- II. **State Government of Madhya Pradesh** shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. **State Government of Madhya Pradesh**, shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate issued to DGE in form GFR 12C in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred scheme guidelines and utilization certificate furnished by the State Government of Madhya Pradesh.
- VI. The State Government of Madhya Pradesh is requested to utilize the said amount as second installment.

The expenditure involved is debit to Major Head "3601" – Labour & Employment for the year 2019-2020 (Plan) and Sub heads/ Minor heads 3601.06.789.26.01.31.

The Government of Madhya Pradesh may kindly transfer the amount to Office I/C, District Employment officer/ Deputy Director, Employment Exchange, Sagar, Madhya Pradesh.
