Sir,

I am directed to convey the sanction of the President of India for release of **Rs. 8,82,700/- (Rupees Eight Lakh Eighty Two Thousand and seven Hundred only)** as 2nd Installment which is 20% of total approved amount - **Rs. 44,13,500 /-** as Grants –in-Aid to State Government of Gujarat, for establishment of Model Career Centers (MCCs) at the **Vadodara Employment Exchanges** under National Career Service Project (Mission Mode Project for Employment Exchanges) during 2016-2017.

2- The release of Grants-in-aid **Rs. 8,82,700/- (Rupees Eight Lakh Eighty Two Thousand and seven Hundred only)** to **State Government of Gujarat** is subject to the following terms and conditions:

- I. **State Government of Gujarat** shall strictly follow the guideline issued vide by DGE on **10th Dec. 2014** and other orders issued by DGE from time to time.
- II. **State Government of Gujarat** shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. **State Government of Gujarat**, shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate issued to DGE in form GFR 19A in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilization certificate furnished by the State Government of Gujarat.
- VI. The State Government of Gujarat is requested to utilize the said amount as second installment.

The expenditure involved is debitable to Major Head "3601" – Labour & Employment for the year 2016-17 (Plan) and Sub heads/ Minor heads .04.331.09.01.31.


