
Sir/Madam,

I am directed to convey the approval of the Competent Authority for the release of Rs. 22,46,820/- (Twenty-Two Lakh Forty-Six Thousand Eight Hundred Twenty only) as Grants-in-Aid to Confederation of Indian Industry (CII) for establishment of Model Career Centres (MCCs) under National Career Service Project at Gurgaon, Mumbai and Chennai, have been approved by the Directorate General of Employment under National Career Service Project for the year 2024-25.

The Pay & Account Officer is requested to transfer the amount in the name of Confederation of Indian Industry (CII), Andhra Association Building, Lodhi Road, New Delhi A/c No. **56321003740, IFSC- SBIN0060321**, State Bank of India, New Delhi for Rs. 22,46,820/- (Twenty-Two Lakh Forty-Six Thousand Eight Hundred Twenty only).

Confederation of Indian Industry (CII), Andhra Association Building Lodhi Road, New Delhi may transfer the Grants-in-Aid to the respective bank accounts of its centres at Gurgaon, Mumbai and Chennai as per Annexure. Further, the release of Grants-in-Aid to the States is subject to the following terms and conditions.
 - i. The Confederation of Indian Industry (CII) shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc., in accordance with the Governments norms.
 - ii. The Confederation of Indian Industry (CII) would require submitting a consolidated Utilisation Certificate (UC) (as per GFR 12C) on utilization of the total released fund to the Directorate General of Employment (DGE).

- iii. As this is last instalment of the approved amount for the centres of Confederation of Indian Industry (CII) at Gurgaon, Mumbai and Chennai, therefore, no next instalment of the fund would be released.
4. The expenditure involved is to be debited from the Budget Head 2230.02.101.10.01.31- Grant-in-Aid of NCS (HQ) during the financial year 2024-25.
5. This issues with the concurrence of IFD vide FTS No 133428, dated 30/01/2025 and approval of JS/DG(E) vide FTS No. vide DGE-G-11011/01/2022- NCS-MCC/1stInst/P3 (comp no.- 133428) dated 11/02/2025.


